

Jean-Paul FORCEVILLE, 62, is a graduate of the École Supérieure de Commerce de Paris (1979) and the École Nationale Supérieure des Postes et Télécommunications (1986). He joined La Poste in 1979.

A high-level institutional career

- **From 1990 to 1992**, he was advisor for budget, finance and planning in the Office of the Minister in charge of Posts, Telecommunications and Space. He then worked in the Office of the Minister of Public Service, State Reform and Decentralization **from 1997 to 1998**, in the same functions.
- **In 1998**, he became Director of Cabinet of the President and of the General Officer of Le Groupe La Poste.

A commitment to the development of Le Groupe La Poste international activities

- **In 2001**, Jean-Paul Forceville was appointed Director of External Relations and, **in October 2004**, Director of European and International Affairs.
- **From 2014 to 2018**, Jean-Paul Forceville is Director of Regulation, Institutional and European Affairs for Le Groupe La Poste.
- **From 2011 to 2014, and again since 2019**, he is Chairman and Chief Executive Officer of SOFREPOST, a La Poste subsidiary dedicated to international consultancy in the postal industry.
- He chaired the Mediapost Vietnam Board **from 2011 to 2014**.

A recognized experience in the Universal Postal Union and Restricted Unions

- **Since January 2011**, he has been chairing PostEurop, a Restricted Union of 52 European postal operators in charge of the universal service. He is also a member of the Board of PUMed, a Restricted Union of 22 postal operators from around the Mediterranean.
- Within the Universal Postal Union, he chaired a Congress Committee in **Doha (2012)** and in **Istanbul (2016)**.
- He co-chairs Committee 2 "Physical Services and E-Commerce" of the Postal Operations Council **since 2016**. He was elected in **April 2018** member of the Quality of Service Fund Board.
